As the BIML Director, it my pleasure to address to our SIM colleagues a message from the OIML.

Unfortunately, due to special circumstances, this year we will not be able to participate in the activities of the annual SIM week. Nevertheless, SIM is a very important liaison organisation for us and we look forward to participating in future meetings.

There have been a number of changes in the BIML and the OIML and I would have liked to present and discuss them with you in person. However, I hope that the short report accompanying this letter will provide you with an overview of our current activities.

Secondly, during the week of October 20 to 25, we will be holding the annual meeting of the CIML, in Bratislava, Slovak Republic. One of the regular activities during the week is the Round Table of RLMOs. The main topic is to present the key legal metrology activities in the regions and propose better ways to cooperate between the regions and the OIML. I look forward to welcoming SIM representative(s) to the meeting.

I would like to highlight one example of OIML and SIM cooperation, which reflects the suggestions received from SIM members implemented in the work of the OIML. This is the addition in our Recommendations of a special part for the periodic verification of instruments.

The OIML is very interested to continue to increase the participation of SIM members in all OIML activities.

<u>Recognizing</u> the significant progress which has been made in efforts to assist in building the capacity of legal metrology institutions and their staff in the CEEMS community,

<u>Noting</u> the reports and advice from the Advisory Group on matters concerning Countries and Economies with Emerging Metrology Systems,

<u>Instructs</u> the Bureau to continue its efforts to promote and participate in capacity building activities, both through the program of OIML Training Centers, and through training courses and regional activities organized by other organizations,

<u>Instructs</u> the Bureau to continue to work with the constituent bodies of the International Network on Quality Infrastructure (INetQI – previously DCMAS Network), in particular the BIPM, to identify new initiatives where the OIML can make a direct contribution,

<u>Instructs</u> the Bureau to continue developing the OIML website so that it provides up-to-date information on capacity-building initiatives, including training materials, and to maintain the database of experts available to contribute to such work,

<u>Instructs</u> the Bureau to ensure that the further development of its systems supporting OIML technical work takes account of the need to involve CEEMS in such work,

<u>Instructs</u> the Bureau to continue using the OIML Bulletin and the OIML website to facilitate the exchange of new ideas, and in particular new approaches to legal metrology,

<u>Noting</u> the particular contribution that research can play in promoting and evaluating new approaches to legal metrology, <u>instructs</u> the Director to take this into account when considering projects which can be supported by the special fund created by the 14th Conference,

<u>Requests</u> its President, Vice-Presidents, the Chair and Vice-Chair of the CEEMS Advisory Group, the Chair of the OIML-CS Management Committee, and the Bureau to take particular account of the needs of CEEMS during involvement in activities related to Objective 5 in the OIML Strategy (OIML B 15:2011),

<u>Requests</u> Technical Committees, Subcommittees and Project Groups to take note of the demand from CEEMS to ensure Recommendations and other publications take more account of the needs of CEEMS,

<u>Requests</u> the OIML-CS Management Committee to ensure that the needs of CEEMS continue to be addressed in the further development of the OIML Certification System,

<u>Urges</u> Member States to consider what support they can give to future OIML Training Centers or other initiatives aimed at assisting CEEMS,

<u>Urges</u> Member States to be ready to propose conveners for projects to produce other documents of interest to CEEMS and to take advantage of the training which is available for potential conveners, and

<u>Urges</u> both Member States and Corresponding Members to consider opportunities to second staff to the Bureau in order to develop the skills and experience of appropriate individuals.

# 7 Convener and secretariat training

Over the last two years, the OIML has conducted a total of nine training courses for TC/SC secretariats and Project Group conveners of the OIML's technical work. Two more courses were held in 2019, in Canada and in Berlin, which completed the initial phase of this training, and a long-term plan will now be established to provide ongoing training to ensure that all secretariats and conveners are kept up to date. The intention of this training is to improve efficiency in the development of OIML Recommendations, and to ensure that this work complies with the *Directives for OIML Technical Work*.

# **8** OIML Certification System (OIML-CS)

The OIML-CS was launched on 1 January 2018 and replaced the OIML Basic Certificate System and the Mutual Acceptance Arrangement. Following CIML approval to extend the scope of the OIML-CS in October 2018, there are now 37 categories of measuring instrument in the OIML-CS; three categories are in Scheme A and the remainder are in Scheme B. Those categories in Scheme B will transition to Scheme A over the next couple of years.

The requirements for the participation of OIML Issuing Authorities and their associated Test Laboratories in Scheme A or Scheme B are the same, but the method of demonstrating compliance is different. OIML Issuing Authorities will be required to demonstrate compliance with ISO/IEC 17065 and Test Laboratories will be required to demonstrate compliance with ISO/IEC 17025. For participation in Scheme B, it will be sufficient to demonstrate compliance on the basis of "self-declaration" with additional supporting evidence. However, for participation in Scheme A, compliance shall be demonstrated by peer evaluation on the basis of accreditation or peer assessment.

There are currently 12 OIML Issuing Authorities and 25 Test Laboratories approved under the OIML-CS, with 30 Utilizers and Associates. Utilizers and Associates have declared that they will accept and utilize OIML Certificates and/or OIML type evaluation reports as the basis for granting national or regional approvals. The second meeting of the OIML-CS Management Committee (MC) was held in Delft, Netherlands on 20–21 March 2019.

There are now 37 instrument categories in the OIML-CS. R 49, R51, R 60, R 76 and R 117 are now in Scheme A. R 46 and R 137 will transition to Scheme A on 1 January 2020. Other Recommendations will transition over the next couple of years.

An OIML/APLMF Seminar on the OIML-CS took place on 15–17 July 2019 in Hangzhou, P.R. China.



## 9 Countries and Economies with Emerging Metrology Systems (CEEMS)

## 9.1 Experts list

Many of the authorities in the CEEMS community have expressed a wish for readily accessible information on experts who can assist them by providing advice or training in connection with their legal metrology activities. A list of experts has been compiled, drawing on the knowledge of CIML Members and others who are active within the OIML.

Each expert on this list is known to his or her CIML Member as having previously provided advice or training on legal metrology issues to governments and/or legal metrology authorities. They have confirmed their availability to undertake similar assignments in the future.

However, the OIML does not endorse or recommend particular experts, and accepts no liability for the use of an expert and the services that they provide.

## 9.2 OIML Training Centres

Since 2016, the OIML has run a number of training courses on various aspects of legal metrology. Several of these were funded and logistically supported by P.R. China under their initiative to establish an "OIML Pilot Training Centre". More recently, other funding and organisational models have been explored, and courses have been run in Kenya and in Cuba with funding from the OIML and the PTB. The OIML is now formalising this process by establishing a framework document for OIML Training Centres, with the intention of expanding the programme for such training under various donor funding models.

#### 9.3 CEEMS Advisory Group

The OIML's activities in favour of CEEMS are overseen by an Advisory Group, which has established a workplan to ensure that the needs and concerns of these countries are prioritised throughout the OIML's work. A secondee from P.R. China is currently working on the development and implementation of this workplan at the BIML.

## 10 e-Learning

The legal metrology e-Learning Platform provides an accessible, comprehensive and interactive way of understanding the implementation of many common legal metrology activities.

At present, the platform is available in English. The French and Spanish translations are ready and will be integrated to the system.

A full revision of the material is also programmed. An e-Learning seminar will be held on 21 October 2019 in conjunction with the 54th CIML Meeting.



# 11 INetQI (previously DCMAS Network)

The OIML most recently chaired this group from 2016–2018. During this time, the main achievements were:

discussions and agreement on a common definition of "quality infrastructure" and "quality policy", change of name from DCMAS Network to *International Network on Quality Infrastructure* (INetQI), World Bank Group and WTO joined the network,

website overhauled, but still needs work to convert to INetQI and make access easier.

A UNIDO led event was held in Brussels in April 2019, to which INetQI members were invited. INetQI met in November 2018 and May 2019, and will meet again in November 2019.

# 12 OIML Task Group 2023

At its 53rd meeting, the CIML created a "Task Group 2023", to consider ideas, develop proposals and identify strategies to be put forward to the 54th CIML Meeting in 2019 and the 16th Conference in 2020.

The group consists of the CIML President, the two Vice-Presidents, the BIML Director, the two Assistant Directors, and two PC members.

The Task Group met in March 2019 in conjunction with the meeting of the Presidential Council.

# 13 Current priorities of the OIML

The current priorities in the work of the OIML are the following:

- working closely with RLMOs, including SIM;
- improving the ongoing technical activities;
- implementation, evolution and promotion of the OIML Certification System (OIML-CS);
- meeting the needs of Countries and Economies with Emerging Metrology Systems (CEEMS);
- cooperation with other organisations to promote metrology as an important part of a sound quality infrastructure (QI) of a modern economy; and
- upcoming: Metrology for Digitization of Economy and Society.

# 14 Closing message

The OIML is looking forward to an even closer and deeper relationship with SIM and its members, and we are committed to working with SIM to advance legal metrology.

We would like to encourage greater contributions (articles, updates and technical papers) from SIM and its members to publish in the OIML Bulletin. The work of one group or Region is always of interest to others, and in this way the aims of the OIML can be focussed in a common effort.

We look forward to visiting, enhancing relationships with and serving the needs of SIM and OIML Member States.
