The number of inspectors were not enough to perform verifications to all of Colombia.





The Superintendency of Industry and Commerce must create a system of procedures that allows digitizing part of the information from the metrological verifications that were carried out.


The number of inspectors was still insufficient to carry out verifications to all of Colombia.

Calibration certificate was required periodically in accordance with what was established by the manufacturer. This is still the case for instruments that do not have metrological technical regulation.

Any instrument could be traded on the market, regardless of its quality.



There was no computer tool that allowed the information collected in the metrological verifications to be stored.



LAW 1753 of 2015 NATIONAL DEVELOPMENT PLAN- ARTICLE 16

Legal Metrology Information System (...). The Legal Metrology Information System (SIMEL) is created, administered by the Superintendency of Industry and Commerce, in which producers and importers, repairers and users or holders of measuring instruments subject to metrological control must be registered.

"(...) The Superintendency of Industry and Commerce will designate by administrative act the Authorized Metrological Verification Bodies (OAVM), the geographical areas in which they will act exclusively, the measurement instruments that they will verify. (...) "


Actions of those involved in metrological control:



CONCLUSIONS

The measuring instruments are checked periodically and must conform to the maximum permissible errors.



The SIC has an accredited calibration laboratory for mass and volume magnitudes.

There is the Legal Metrology Information System –SIMEL. New instruments must demonstrate conformity according to the corresponding metrological technical regulation.

04. FOURTH STAGE





PREPACKAGED PRODUCT INFORMATION SYSTEM

A <u>unified information</u> system on prepackaged products, where each country can upload the information on the metrological control it has carried out.

Centralize the rapid exchange of information between the control authorities of the countries, providing <u>reliable, timely and truthful</u> information on the verifications realized on prepackaged products.



System that <u>allows data analysis</u> such as: products that are most verified, country with the highest number of non-compliances, products with noncompliances.

System that allows control authorities to organize <u>metrological verification</u> <u>operation and strategies</u>.
